Location

The offices are located at the southern end of Edenbridge High Street on the corner of Hever Road within walking distance of the local shops and banking facilities.

There are two railway stations to the north of the Town, one of which provides a route through to Victoria and London Bridge via Oxted and East Croydon and the other provides a service to Tonbridge and, via Redhill, to Gatwick Airport or Reading.

Road access to the M25 is via junction 6 at Godstone, about 10 miles, or junction 5 at Sevenoaks, about 9 miles. Gatwick Airport is about 15 miles by road.

Description/Accommodation

The accommodation comprises a first floor office suite with a private entrance off the Hever Road Frontage. Internally there are three separate offices, kitchenette and wc/shower room. To the rear there are two open parking spaces included in the tenancy.
