Location

Crockham Park is conveniently situated on the west side of the B2026 road between Crockham Hill and Edenbridge, Gatwick Airport is approximately 14 miles away (direct route) or 22 miles via the M25 at junction 6 (approximately 8 miles). East bound traffic can pick up the same motorway at junction 5 at Sevenoaks (approximately 7 miles).

Rail links to London Bridge and Victoria, Waterloo Charring Cross and Reading are accessed either via Edenbridge Town Station or Oxted Station, both being within easy reach of the property.

Edenbridge Town is a short drive and provides a range of retail and leisure facilities.

Nearest supermarket, petrol station and sandwich shop is 4 min (1.7 miles) drive. Local pubs provide hospitality for entertaining.
